REPORT ON ONGOING/EXISTING PROJECTS AND UNEXECUTED PROJECTS

We commenced the year 2025 with two (2) existing projects regarding skill acquisition for youths. Our trainees are Alimat Jamiu and Samuel Oguntokun.

Alimat Jamui: She was enrolled at a tailoring/clothing and textile enterprise named Tee Stitches headed by Mrs. Aminat Oluwatosin-Frank. The agreed duration of the training was for a period of 12 months, starting from September 2023 to lapse in September 2024 but we negotiated with the owner, an extension by six months which brought the completion period to March, 2025.

Meanwhile, the training ended abruptly towards the end of January, 2025, when a conflict came-up between Madam Oluwatosin and our trainee, Alimat which by extension also involved Alimat's Mother Mrs. Shakirat Jamiu. Our effort towards reconciliation didn't yield the desired result. We however made arrangement to obtain certificate for the trainee, this suffered a setback as Madam Oluwatosin-Frank delivered a set of twins during that period, she was away for a long time, by the time she resumed on skeletal basis, our trainee, Alimat had travelled out of Lagos to Ilorin where she secured admission in a University. We are looking forward to this coming December when there would be holiday. We desire to bring that training to a logical conclusion where we would carry out certificate presentation and a short words of encouragement and photographed.

Samuel Oguntokun: He was also enrolled at a tailoring/clothing and textile enterprise, named Ade's Creation Clothing and Textile Fashion Designer. With this particular trainee, we do not have conflict, our major challenge with him has been his level of assimilation. We just keep encouraging him.

PROPOSED PROJECT FOR 2025

At the beginning of the year in January, 2025, we presented budget proposal for two (2) projects as follows:

- Enrolment of youths for skill acquisition program on installment payment basis
- Items donation to a public secondary school at Bariga, Lagos.

Upon review and instruction, we were advised to hold on and watch out for a strategic project that may have been in the public eye. This is a decision I respect and considered very strategic as it aligned with the goal of the organization.

In the month of February, 2025, We transited to a period of receiving instructions and liaising with madam regarding project proposal and execution. So, in the month of April, we were asked to visit orphanages for the possibility of impacting orphans. We visited a number of orphanages (about 4) for enquiries and report of the various visits were forwarded to madam. We are uncertain about executing a project in that direction.

We renewed our web hosting and domain name in the month of July to ensure our website is up and working.

In September we were asked to and submitted a proposed budget for possibility of carrying out a project in November/December.

We strongly believed that we shall attain clarity and direction in the coming months as we continue to keep our moral and spiritual antenna in alignment with the goals and objectives of Adesuwa Osagie Foundation. (AOF)
